Dear Families,

Attached is your registration form for the 2023-2024 school year for our School Age Care Program for children in grades K-5. Please take a moment to fill it out and and drop it off at Clyde Brown or mail it to Judy Reilly at Clyde Brown School 7 Park Road, to arrive on/before Thursday, June 15, 2023. (Please do not email your form.) Please be certain to fill in the days/sessions you intend to send your child. Please choose carefully. Once all of the forms have been processed your enrollment will be confirmed with an email which will include your tuition amount along with a \$23.00 registration fee.

ALL enrollment requests received <u>after</u> the June 15th deadline, regardless of the reason it is late, will be entered on a waitlist and we will contact you in the event that we are able to accommodate you at any point during the school year.

This program is designed to meet the needs and schedules of parents and their children and runs in conjunction with the school calendar.

This program is offered Monday through Friday from 7:00 a.m. to the start of school and again from school dismissal until 6:00. You may choose between 2 and 5 days/week. If less than 5 days, the days must be consistent from week to week. There will be additional programs offered for some early release days and some no school days for an additional fee. We also intend to offer full day vacation programs for February and April vacations as well as summer.

Please note that there will be no schedule changes processed between August 1st and September 30th.

Staffing for the Extended Day Program is by qualified personnel. The adult to child ratio is typically 1:10, to ensure proper supervision and to keep our children safe.

Once your child has been confirmed (See last page) we will presume that s/he is enrolled for the full academic year. That said, we do understand that circumstances may arise that do require a change. If that occurs, please know that you must request that change in writing as soon as possible.

This program opens for Grades K-5 on the first day of school for your child's grade and thereafter in accordance with the Millis Public Schools schedule. There are ten (10) equal payments due for the school year. The first tuition payment is due on or before **August 1,2023 and is nonrefundable**. This is Payment #1 of 10. Subsequent payments are due on the first (1st) of the month.

Tuition rates are included on the attached registration form. Please note that tuition rates are subject to review. You will be notified in advance of any changes. The rates are divided into ten (10) equal payments. **PAYMENTS ARE DUE THE FIRST OF EVERY MONTH**. You are responsible for making sure your payment is sent in a timely manner. **We will not be sending monthly invoice reminders**. There will be a \$20.00 surcharge for all late payments received after the due date. If you have any questions or concerns, please email Jeanne Noonan at jnoonan@millisschools.org.

Frequently asked question: Yearly tuition is divided into ten equal payments that cover the full school year.

Please note that each payment is for a period of about 18 days which usually fall in more than one month. The first payment due August 1st, covers the first day of school through 9/26/23 (not the month of Sept.). The second payment is due September 1st. The final payment due on May 1st is for the last 18 school days (not the month of June). Tuition is due the 1st of every month. No reminders or invoices are sent out. It is the parent/guardian's responsibility to make payments on-time.

WHAT HAPPENS NOW?

Pre-pandemic, our practice was to accept or place all children for whom an enrollment form was submitted prior to the enrollment deadline. Unfortunately, the <u>staffing situation</u> continues to be very challenging for afterschool programs across the board.

While we continue to explore every avenue to find the kinds of quality staffing that we need to care for all of your children as requested, we are going to move forward with a "rolling admission" as we did for the current school year. What this means is that, shortly after the deadline we will begin to send confirmations to families based on the **priorities outlined below** until we reach capacity with current confirmed staff. As we are able to identify additional staff, we will add children.

Priority Acceptance:

- 1. Any Millis Public Schools' staff children and their siblings regardless of grade.
- 2. Returning children from SY2223 starting with grade 5, then 4, then 3, 2, 1 & Kindergarten & their siblings regardless of grade.
- 3. Returning all other children from years prior to SY2223 starting with grade 5, then 4, then 3, 2, 1 & Kindergarten & their siblings regardless of grade.
- 4. New children starting with grade 5, then 4, then 3, 2, 1 & Kindergarten & their siblings.

NOTE: Each priority level will be done as a lottery, unless we are able to accommodate everyone on that level, until we reach capacity at a ratio of 8:1. This ratio may need to be adjusted depending on the needs of the students.

We understand the anxiety of the unknown when it comes to care for your child. While we don't want to cause you angst at this time, we do want to continue to be as open as possible about the current situation so that you are able to make whatever adjustments that you feel are necessary for your family at this time.
